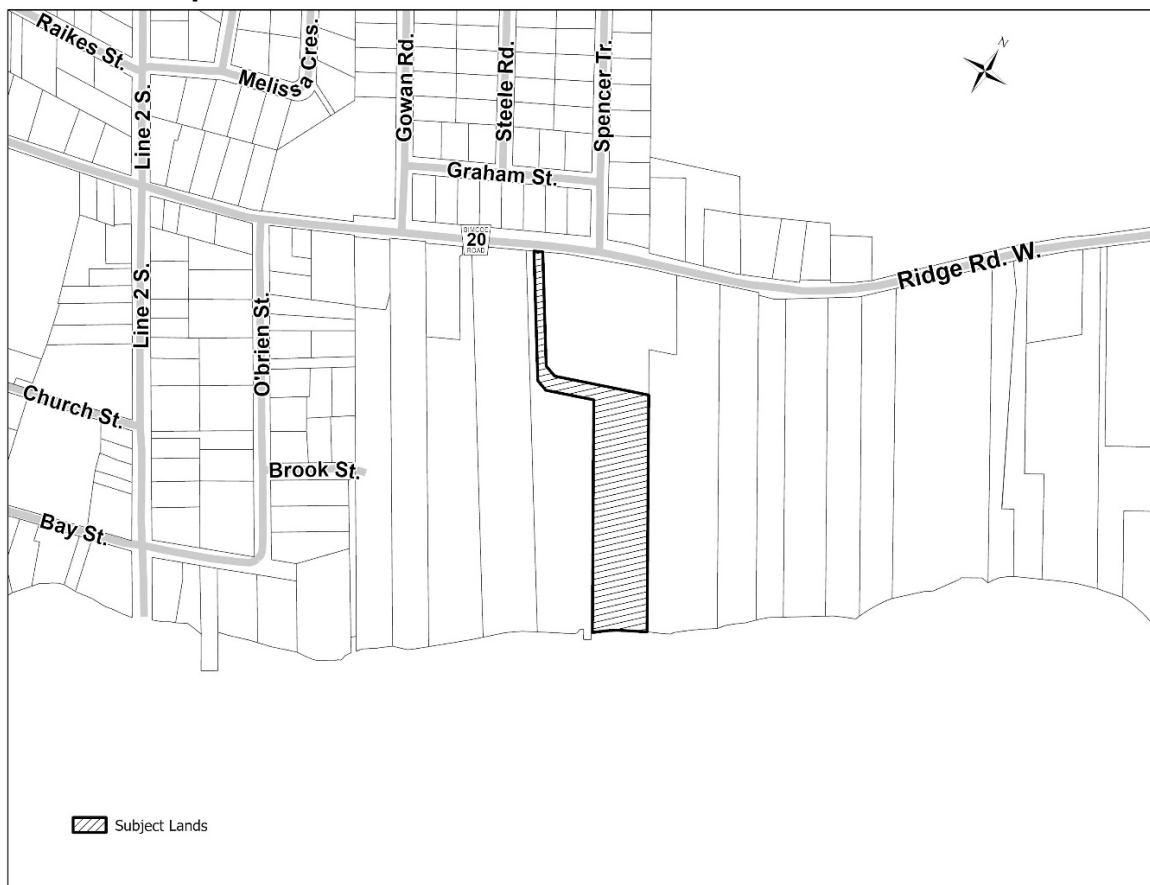

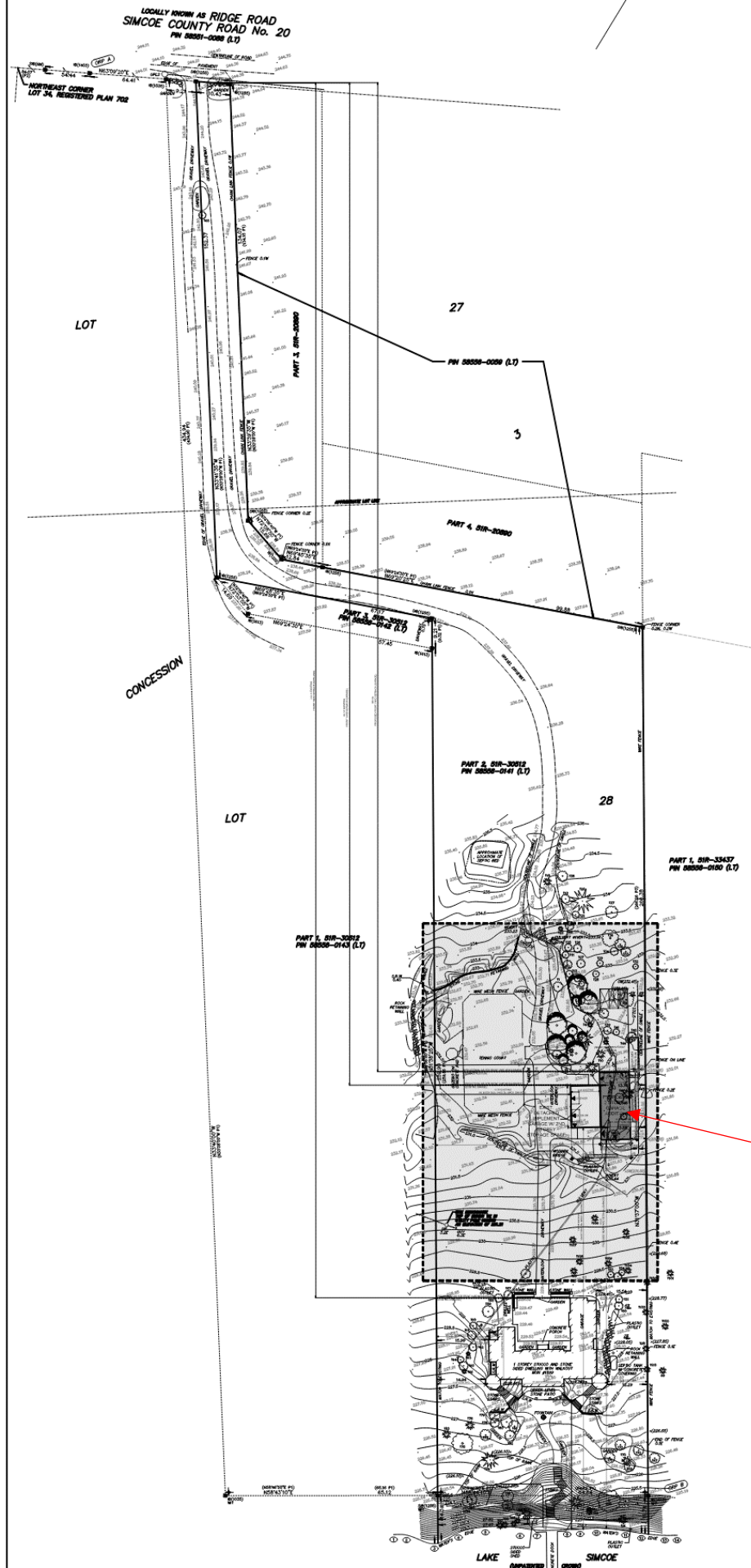

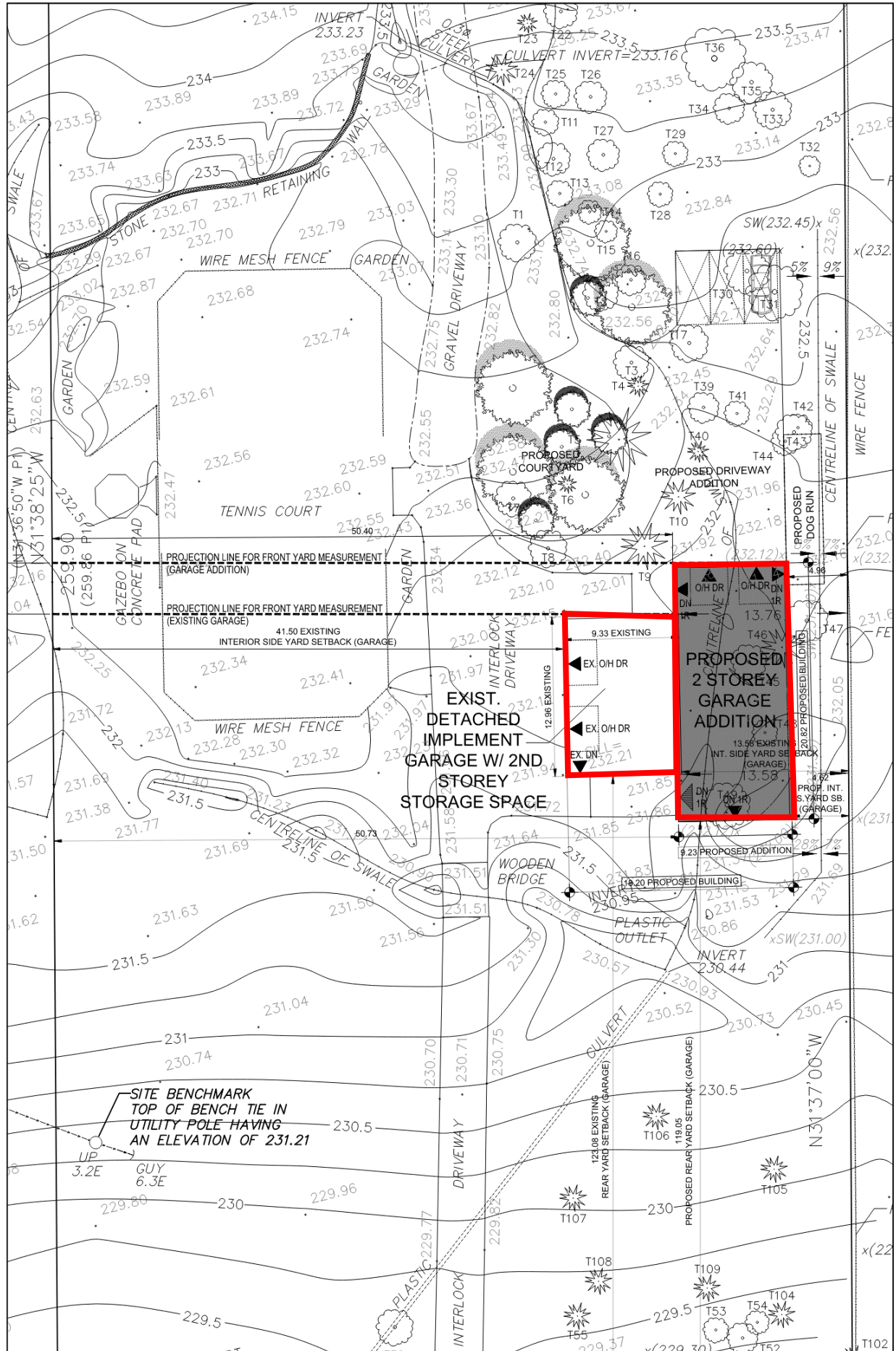
PLAN OF SURVEY SHOWING TOPOGRAPHIC FEATURES

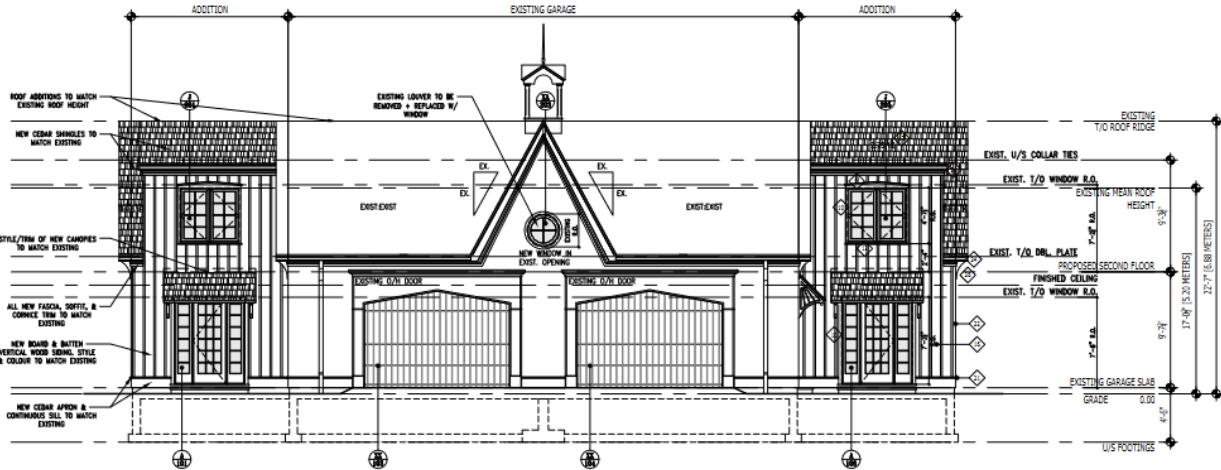

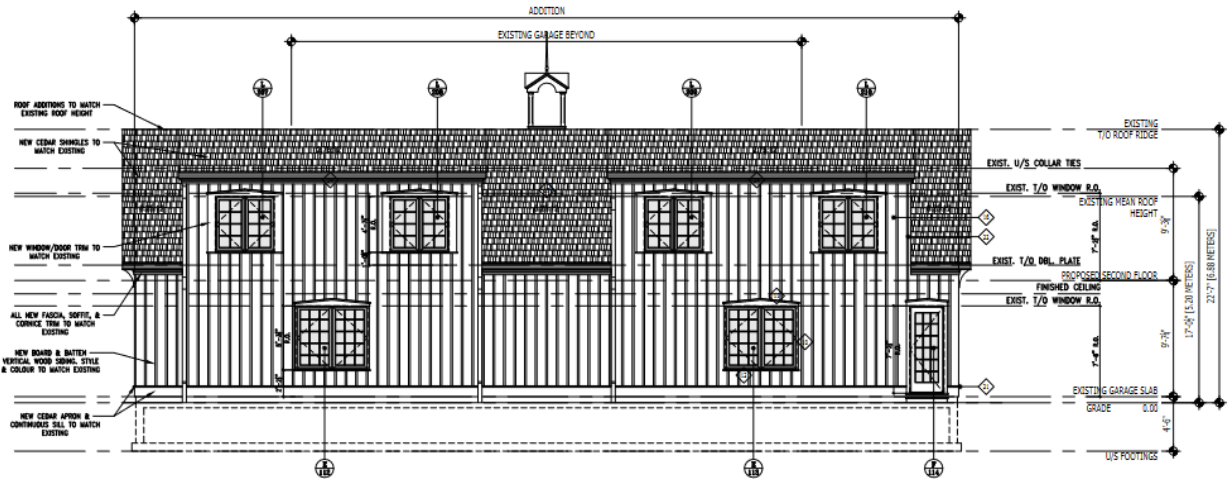

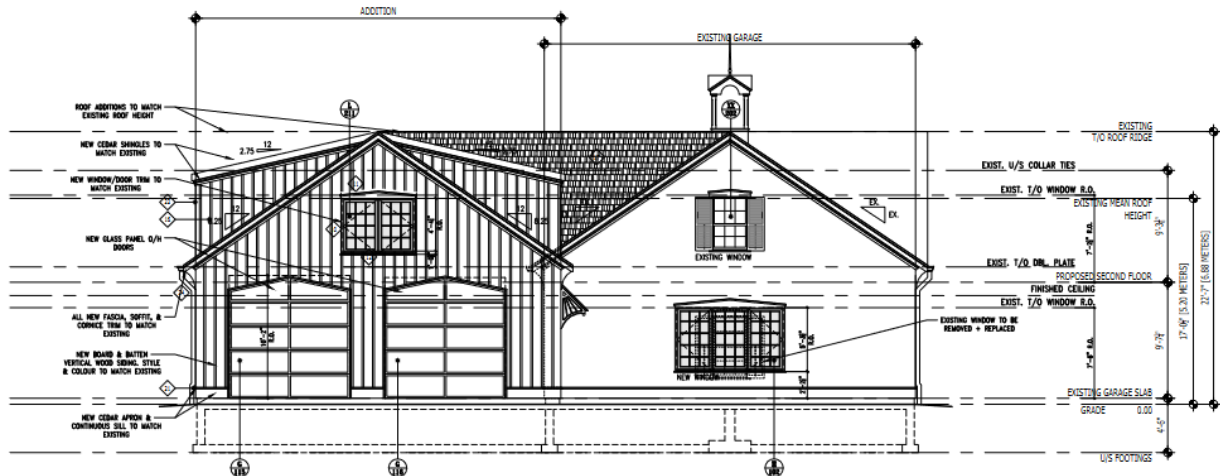

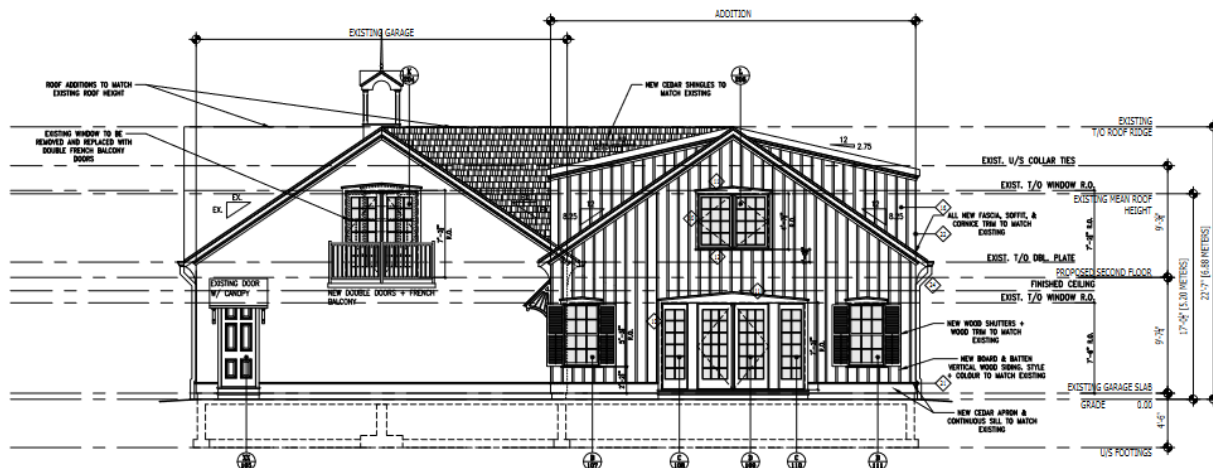

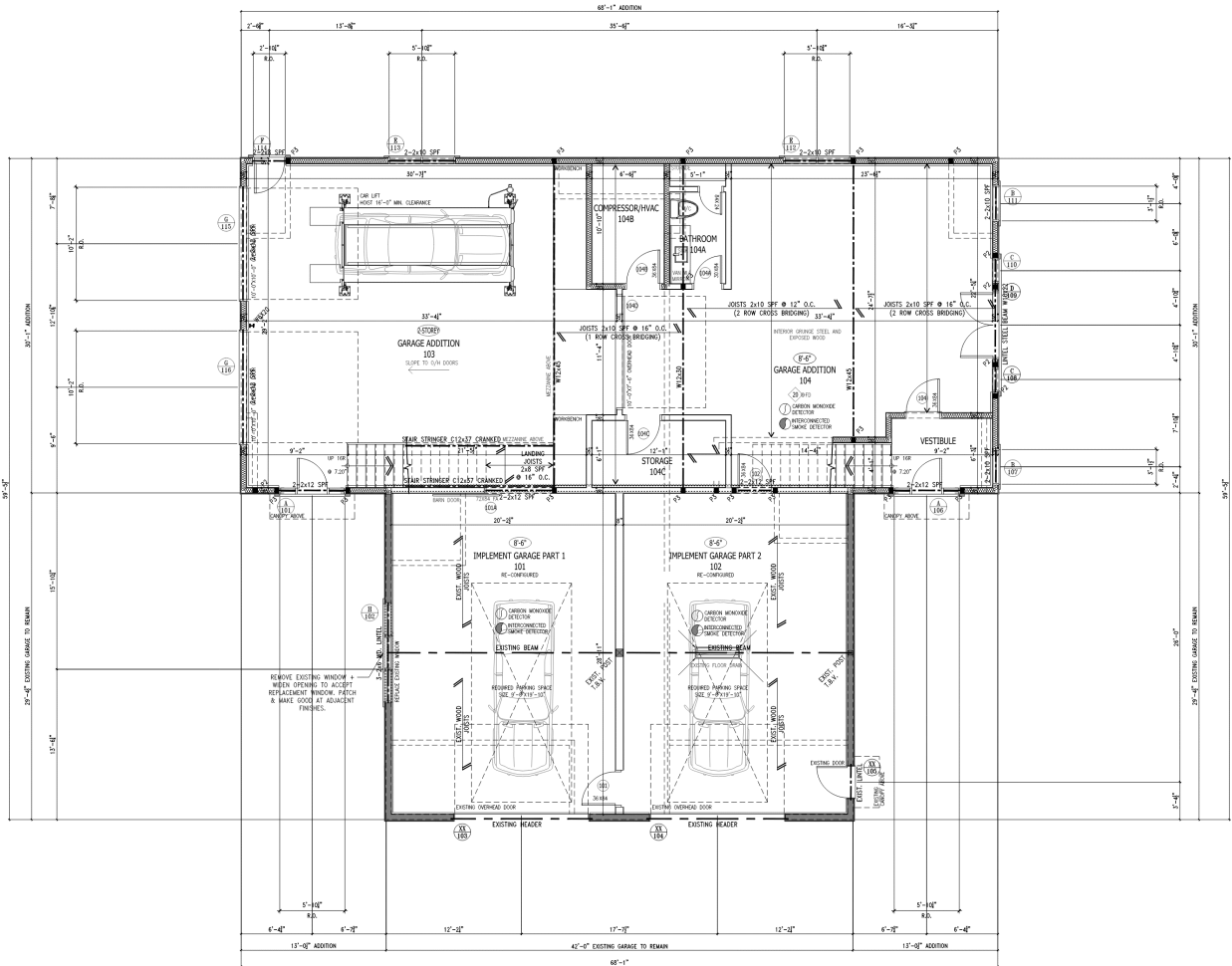


South Elevation:
