Minor Variance Application Notice of Public Hearing



Purpose: The applicants are proposing to build a detached garage for storage purposes. The applicants are seeking relief to the following sections of Zoning By-law 97-95 to allow for the construction of a detached garage that would exceed the height, gross floor area, lot coverage and side yard and front yard setback provisions of the By-law regarding accessory structures:


