Consent and Confidentiality Agreement (“Agreement”)

The Integrity Commissioner for the Township of Oro-Medonte acknowledges receipt of your complaint against one or more Member(s) of Township Council and Township’s Local Boards.

By signing this Agreement, you are acknowledging, accepting, and agreeing with the terms, as set out herein.

You agree that:

- Your complaint has been submitted to the Clerk or the OIC; and,
- Your complaint relates to the application of the Code of Conduct for Members of Township Council and Township’s Local Boards and/or the application of any procedures, rules and policies of the Township’s governing ethical behavior of Members of Council and/or the provisions of the Municipal Conflict of Interest Act (“MCIA”).

You agree to keep confidential all communications and information from the IC and the OIC, including correspondence and draft and final investigation reports. A final investigation report will cease to be confidential once it is included on a Municipal Council open session agenda. The final investigation report may include your identity as the complainant as well as the identity of the Member the complaint was made against.

Any information arising out of the investigation process that is not included in a final investigation report will continue to be held in confidence by you.

The IC and/or the OIC may disclose information received from you to the Member(s) of Council and/or Local Boards whose conduct is complained of and other parties relevant to the investigation.

The IC and/or the OIC may disclose to you the information it receives from the Member(s) of Council and/or Local Boards whose conduct is complained of and other parties relevant to the investigation.

No employee, contractor, or subcontractor of the IC and/or the OIC is liable for anything done or omitted to be done during the complaint and investigation and report process.

The IC reserves the right to terminate the investigation at any time if it determines that the complaint is frivolous, vexatious, or is made in bad faith.
