Police Services

Introduction

The Township of Oro-Medonte is provided police services from the Ontario Provincial Police on a non-contract basis. The municipality receives the revenue from fines issued within the municipality by the OPP. Commencing in 2016, detachment revenue is transferred to the municipality.

The municipality provides a sub-station that is centrally located at Horseshoe Valley.

Government grants relates to Court Security and Prisoner Transportation (CSPT) funding received from the Province. Municipalities have been put on notice this funding may end at any time, thus these grants are not budgeted for.

Other Revenue relates to Detachment Revenue transferred to the Township by the OPP.

Environmental Scan:

- POA Revenues from OPP ticketing continues to trend lower and is common across the County of Simcoe
- OPP levy is now approximately \$3 Million per year for the Township, a slight decrease in 2021 vs 2020 levy

Significant challenges for 2021/2022:

None

2021/2022 Budget Impacts:

• Decreasing POA Revenues continue to impact budgets. 2021 and 2022 revenue budget reduced to reflect actual experience and about 50% of the 2020 Original Budget target
