Purpose: The applicant is proposing to increase the area of a deck attached to a boathouse. The applicant is seeking relief to the following sections of Zoning By-law 97-95:

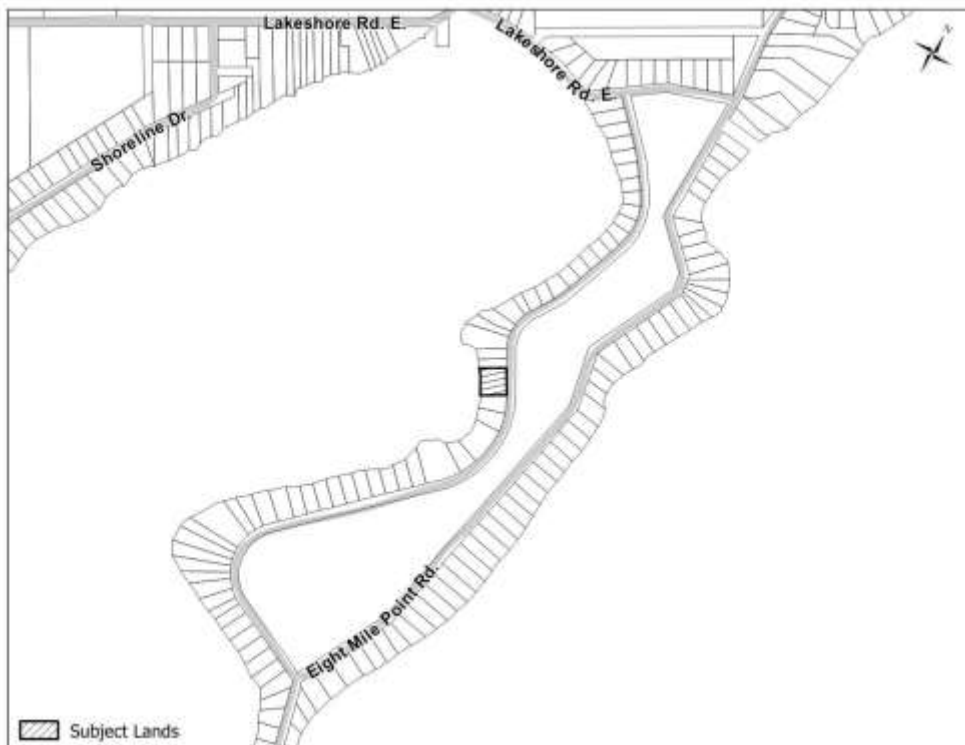
Section 5.7 b) - Decks

<p>Required: Decks either attached to boathouse or stand alone are permitted to be located at the water's edge provided total footprint of deck and boathouse combined does not exceed 70 sq. m. (753 sq. ft.)</p>	<p>Proposed: 120.0 sq. m. (1,292.0 sq. ft.) combined area of the deck and boathouse</p>

Section 5.16 c) - Non-Complying Buildings and Structures

<p>Required: A non-complying building or structure may be enlarged, repaired, replaced or renovated provided that [it]... does not in any other way increase a situation of non-compliance: Currently 106 sq. m. (1,141 sq. ft.)</p>	<p>Proposed: The proposed extension of deck will increase the situation of non-compliance. 120.0 sq. m. (1,292.0 sq. ft.) combined area of the deck and boathouse</p>
