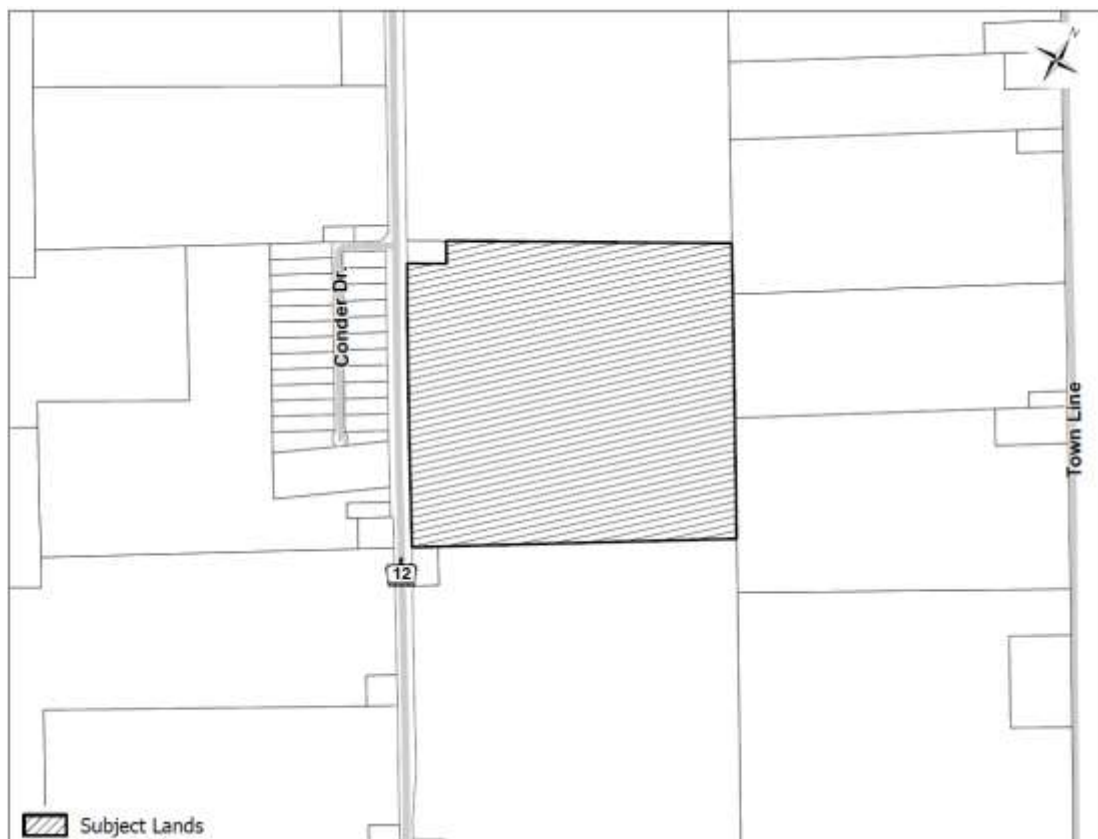

The purpose of Consent Application 2021-B-18 is for a boundary adjustment/lot addition to sever lands from 10087 Highway 12 and merge them with an abutting parcel located at 10125 Highway 12.
