Participate by Phone

If you do not have a computer or smart device, there is an option to participate by a regular telephone. You will be provided with an email containing a link to register prior to the meeting **or** a dial-in number and the meeting ID.

Once promoted to panelist, the meeting Chair will welcome you to the meeting and request that you introduce yourself and speak.

Please note if you are participating by phone that *9 (star nine) on your telephone will give the raise hand option indicating to the host when/if you wish to make an additional comment; and * 6 (star six) will allow you to mute your telephone.

Please note that telephone numbers may be visible to the public; however, every effort will be made to change the number prior to the participant being promoted to a panelist.
