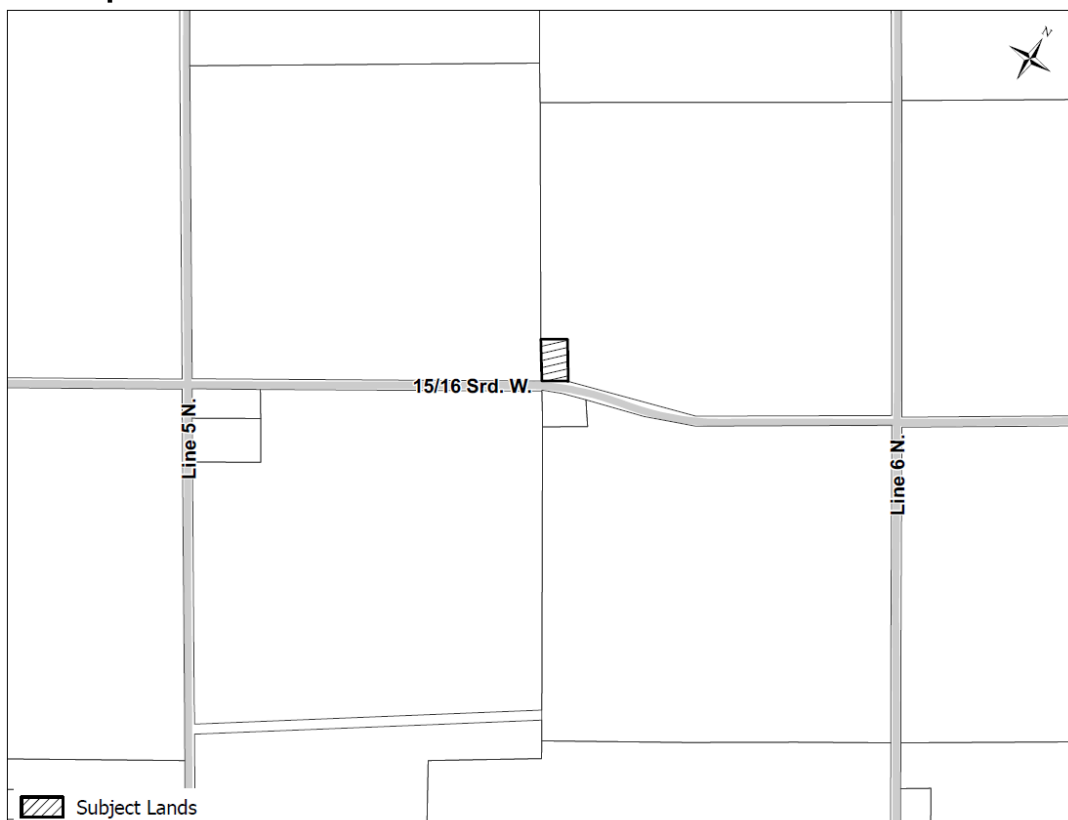

Purpose: The applicant is proposing to establish within an existing dwelling a home occupation described as providing mental health care, including outpatient therapy, to first responders, helping professionals, and those in high trauma sectors. No intensive, extended, residential or overnight treatment is proposed. The applicant is seeking relief to the following sections of Zoning By-law 97-95:

Section 5.12 (d) & (g) – Home Occupations

Required:	Proposed:
5.12 (d): Home occupation shall not occupy more than 35 percent of the gross floor area of the dwelling unit.	Home occupation to occupy 45 percent of the gross floor area of the dwelling unit.
5.12 (g): Home occupation shall not employ more than one (1) employee who is not a resident of the dwelling unit.	Home occupation to employ up to four (4) employees who are not a resident of the dwelling unit.

If you wish to be notified of the decision of the Township of Oro-Medonte in respect to the application, you must make a written request.

Individuals who submit letters and other information to Council and its advisory bodies should be aware that all information, including contact information, contained within their communications may become part of the public record and may be made available through the agenda process, which includes publication on the Township's website.
