2.0 metres (6.5 feet)	1.0 metres (3.2 feet)

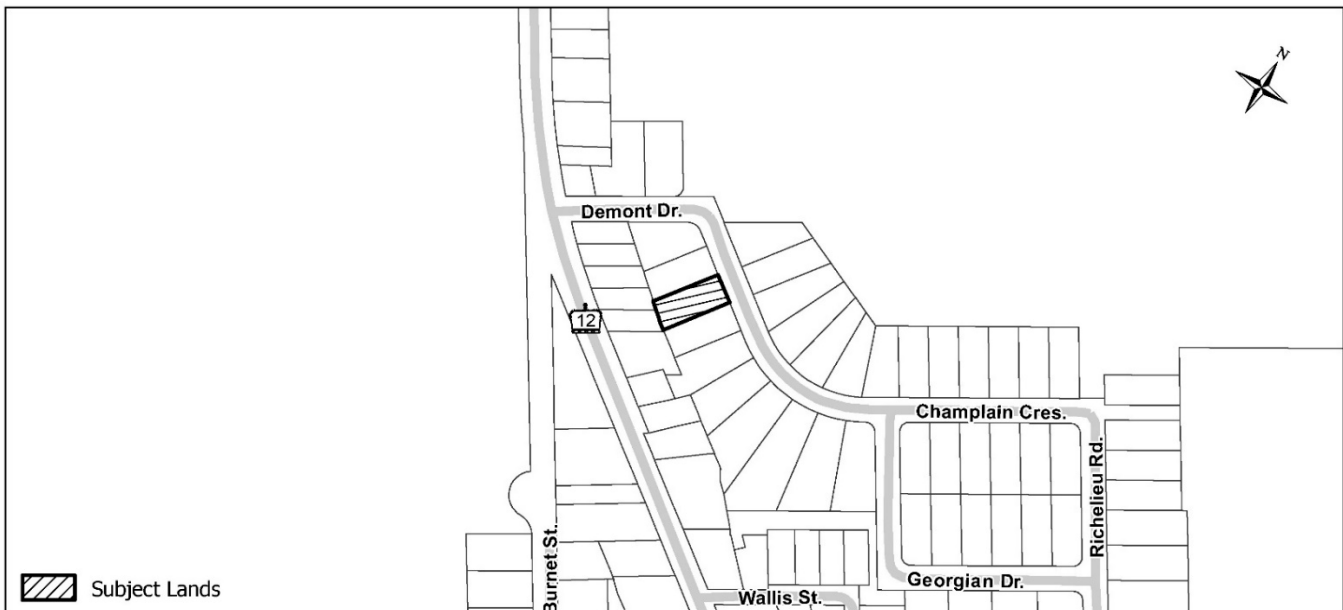
e) Minimum Distance to a Dwelling

1.0 metres (3.2 feet)	0.76 metres (2.49 feet) between roof overhang of detached garage and dwelling

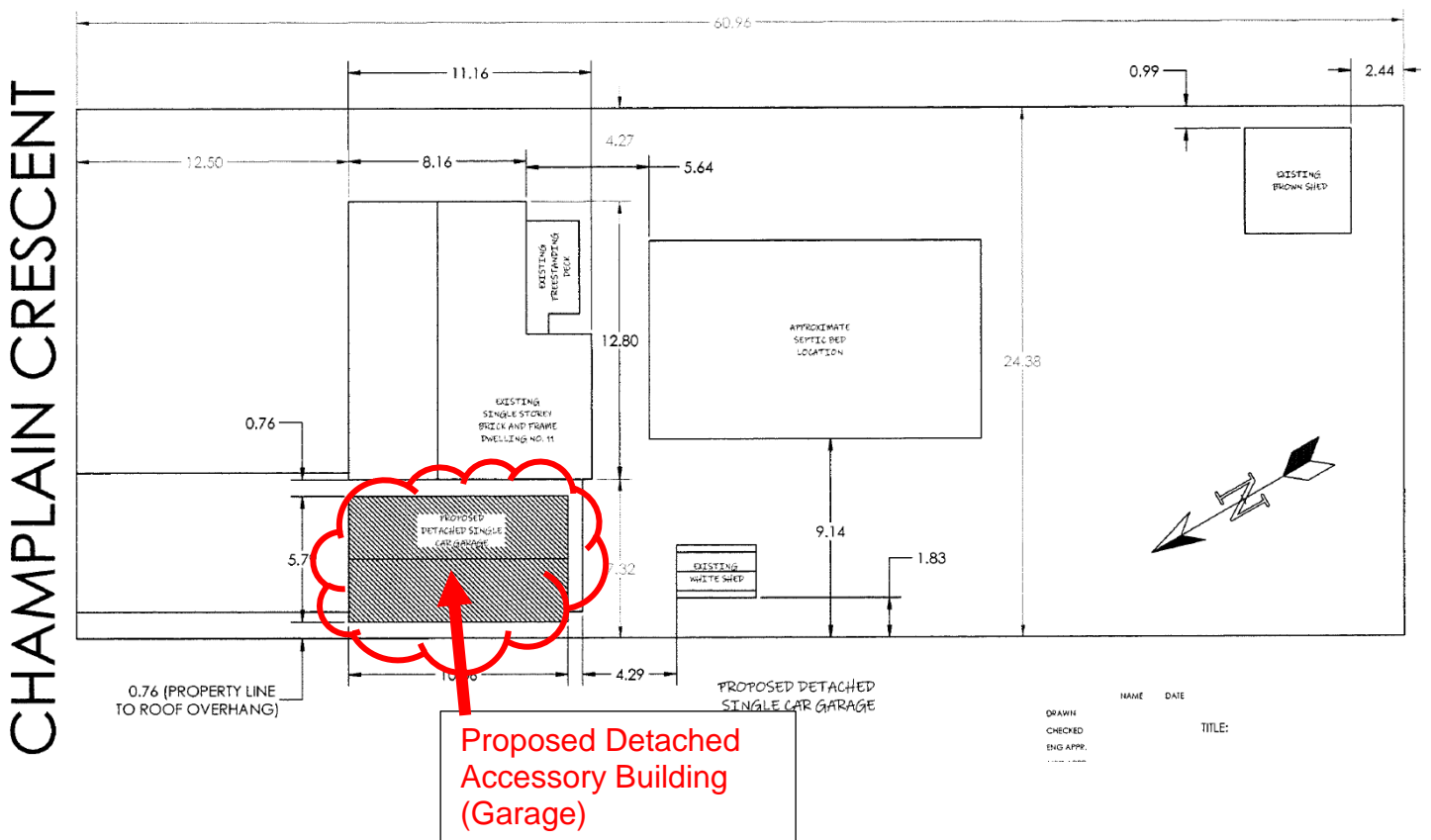
