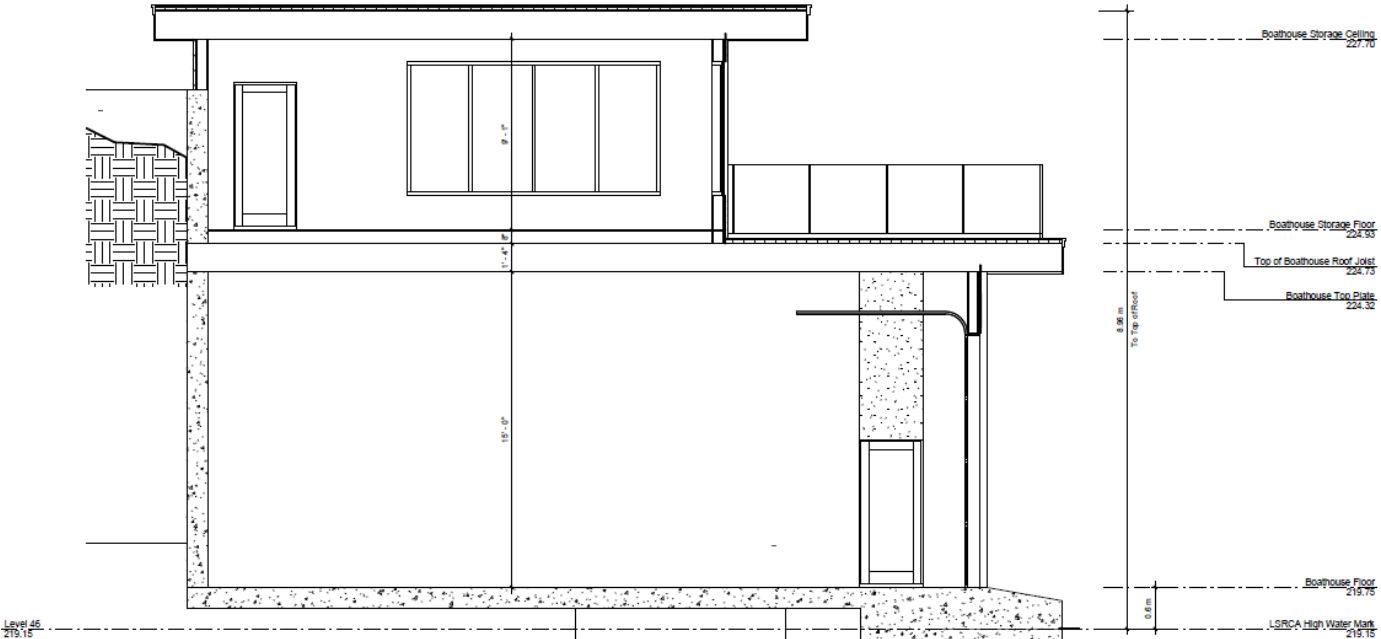

Boathouse Elevation Drawing:

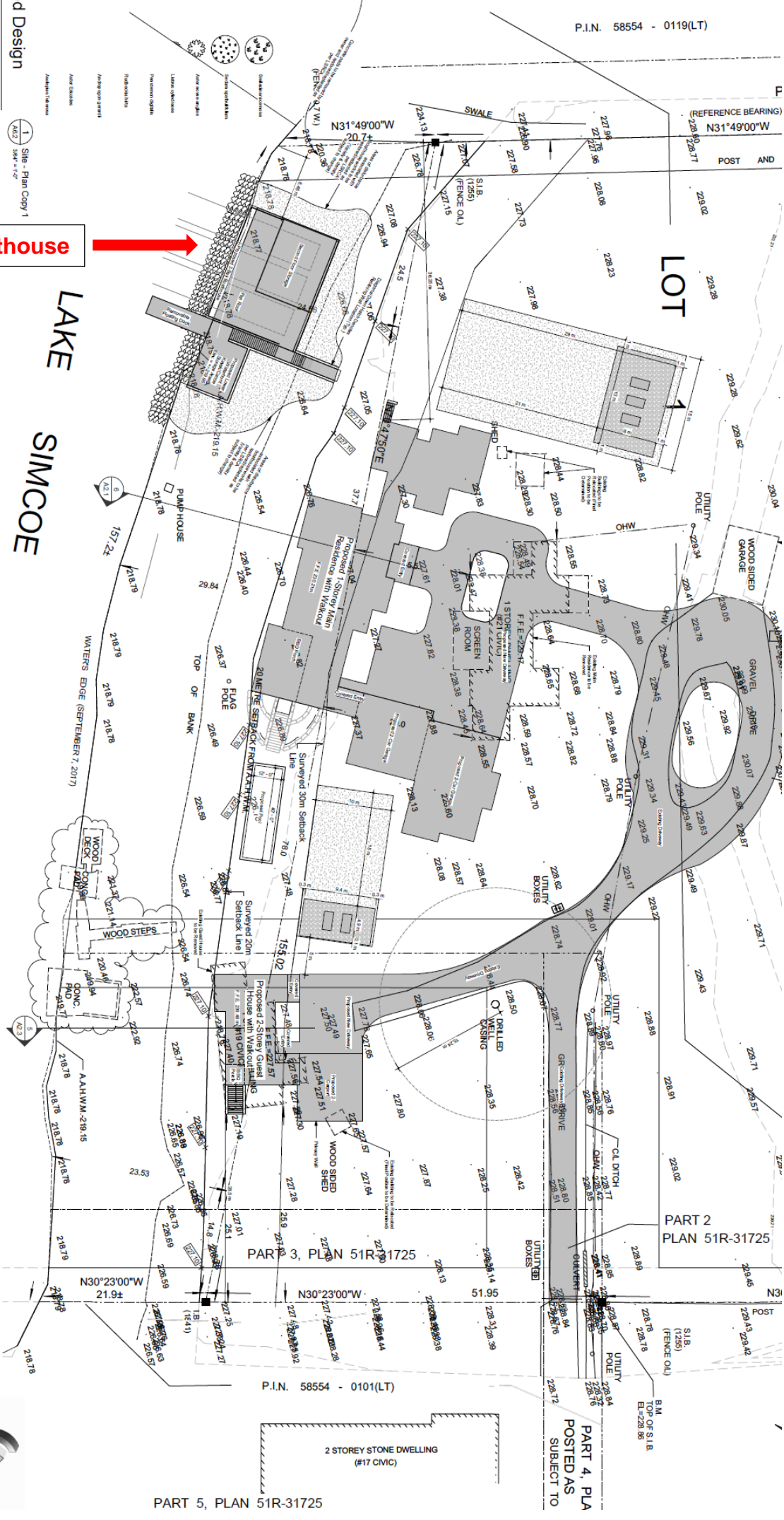
