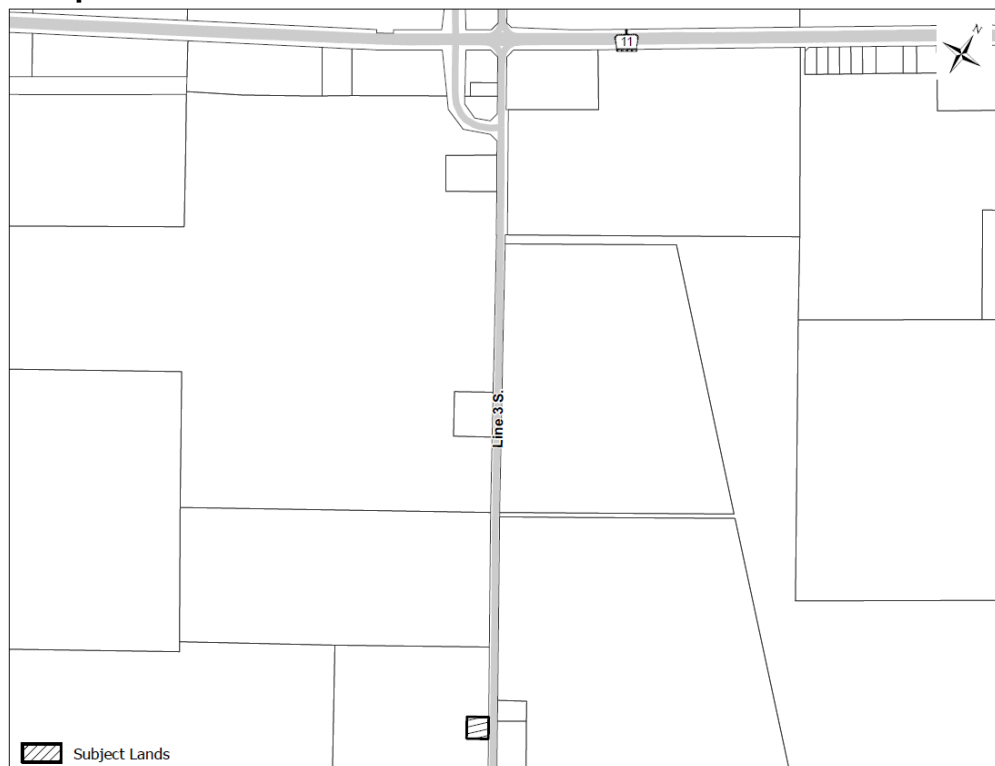
Section 5.1.4 – Maximum Height of Accessory Building

Required: Maximum 100 square metres (1,076.4 square feet)	Proposed: 167.23 square metres (1,800 square feet)

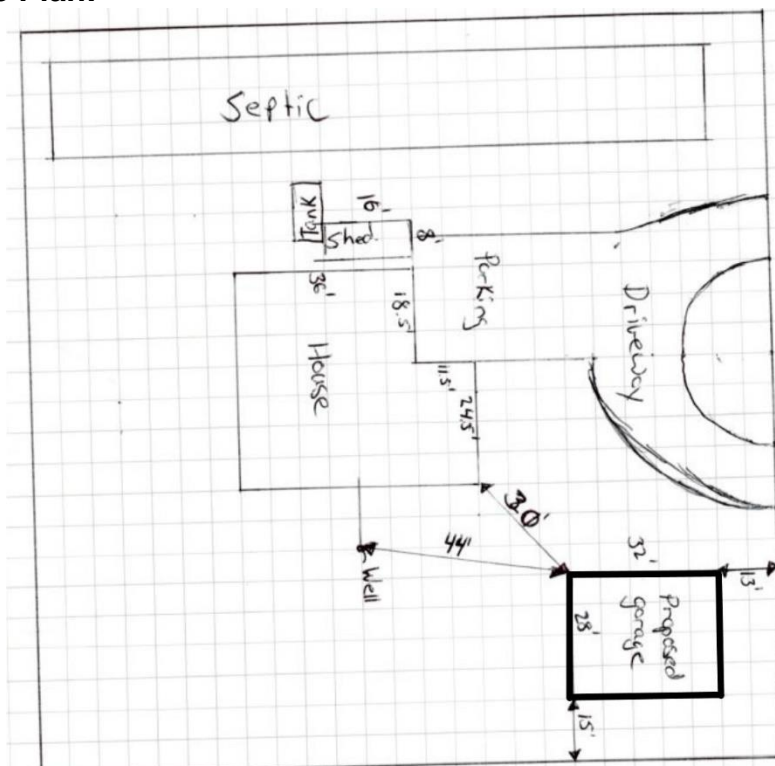
