

**Purpose:** The applicants are proposing to build an addition to the existing single detached dwelling. Minor Variance 2020-A-68 was approved on January 6, 2021 to permit an addition with a setback of 17.2 metres (56.4 feet) from the top of bank of the slope. After obtaining an Engineered Lot Grading Plan, the applicants determined that the addition will be located closer to the top of bank than originally proposed; therefore, they are seeking relief to the following section of Zoning By-law 97-95:


