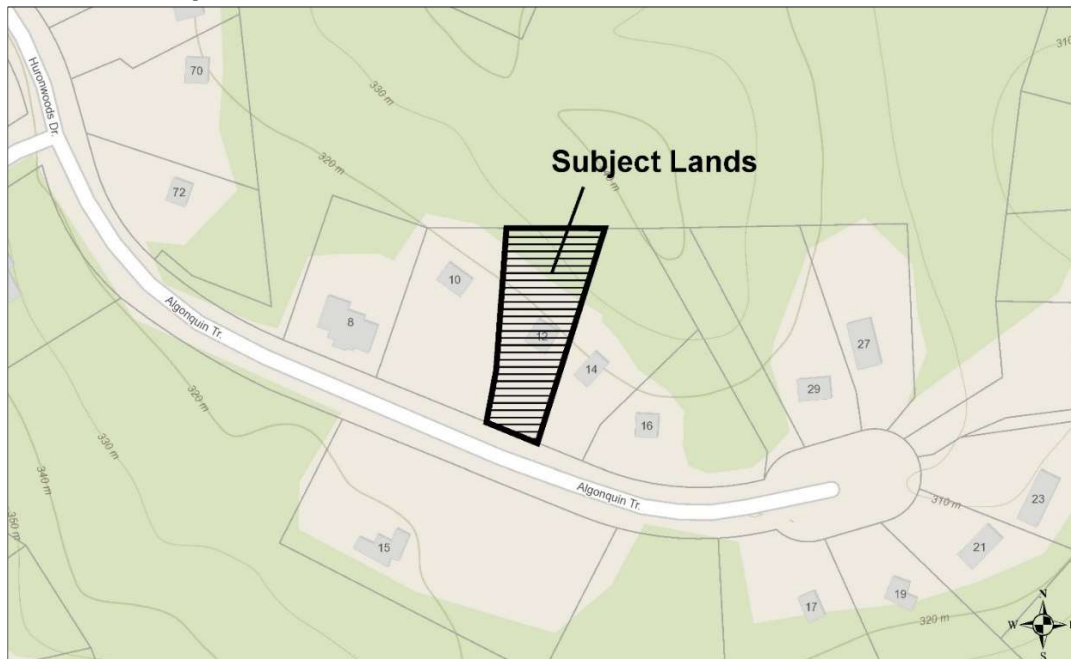
Section 5.1.4 – Maximum height for a detached accessory building (garage)

Required: 4.5 metres (14.7 feet)	Proposed: 5.2 metres (17.1 feet)

Section 5.1.6 – Maximum floor area for a detached accessory building (garage)

Required: 70.0 square metres (753.5 square feet)	Proposed: 1 st floor garage: 72.9 square metres (785.1 square feet) 1 st floor carport: 26.0 square metres (280.4 square feet) 2 nd floor storage: 47.0 square metres (505.9 square feet) Total: 145.9 square metres (1,571.4 square feet)

If you wish to be notified of the decision of the Township of Oro-Medonte in respect to the application, you must make a written request.

Individuals who submit letters and other information to Council and its advisory bodies should be aware that all information, including contact information, contained within their communications may become part of the public record and may be made available through the agenda process, which includes publication on the Township's website.

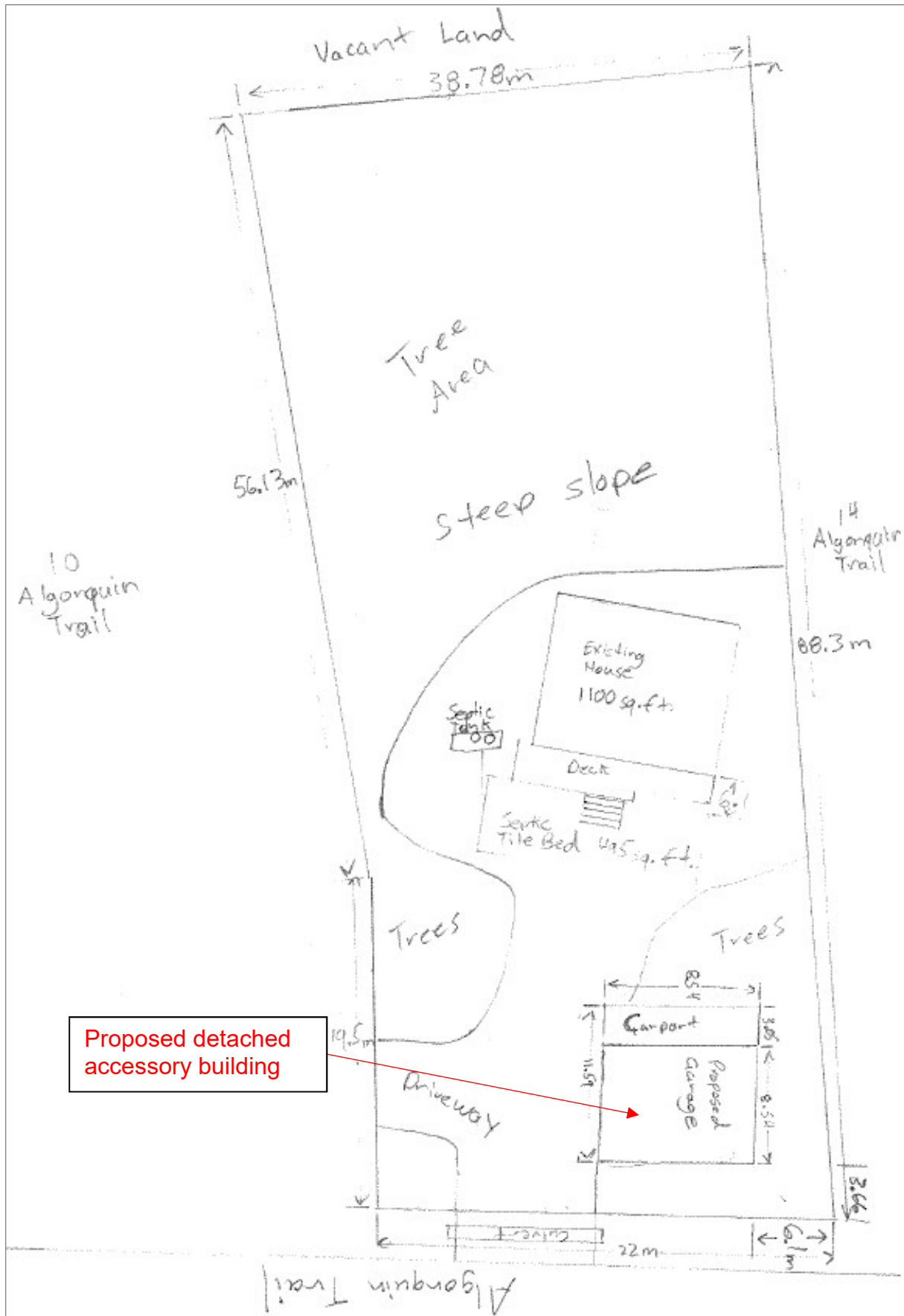
