Section 5.36 Storage/Shipping/Cargo Containers [By-law 2015-192]

Required: No person shall, in any Residential Zone, use any truck, bus, coach, transport truck trailer, streetcar body, railway car body, railway shipping container, or similar structure of any kind, for the purpose of an accessory structure.	Proposed: Permit six (6) shipping containers in the RUR2 zone
