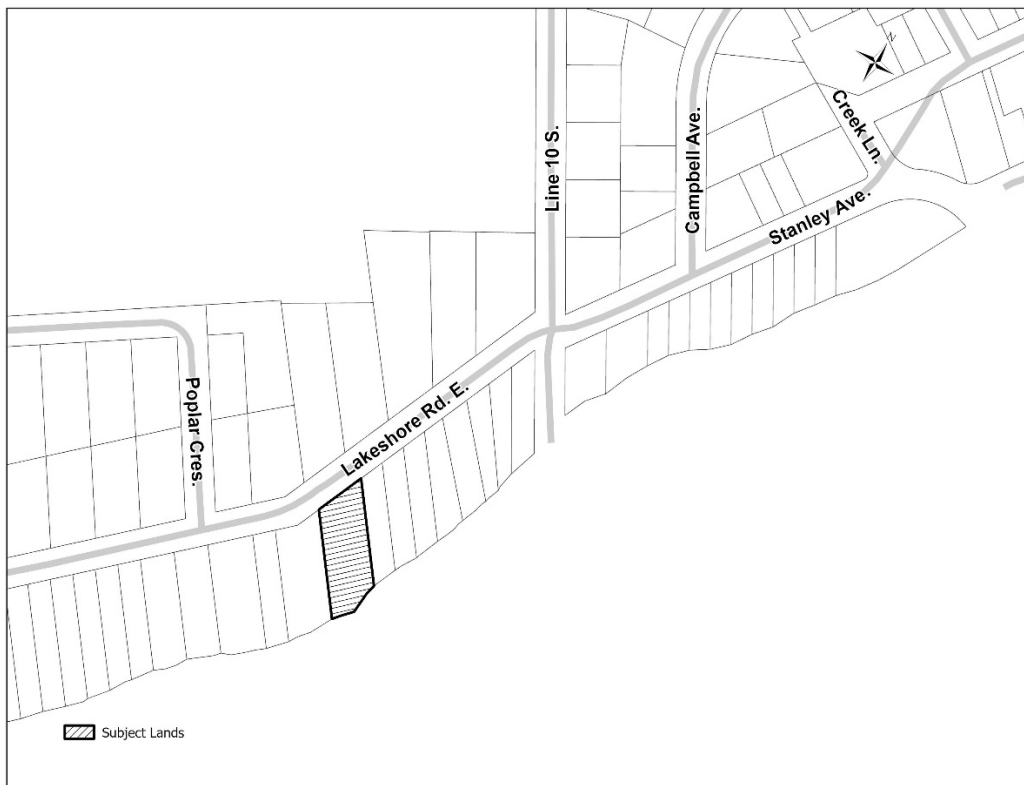
Section 5.1 – Accessory Buildings, Structures and Uses

Required: 4.5 metres (14.7 feet)	Proposed: 4.88 metres (16.0 feet)

Section 5.6 – Boathouses

Required: The highest point of the roof surface or the parapet, whichever is the greater, of a boathouse with a flat roof is no more than 4.5 metres (14.7 feet) above the elevation of the average high-water mark.	Proposed: 7.7 metres (25.3 feet) from average high-water mark to mid-roof of unenclosed second storey gazebo

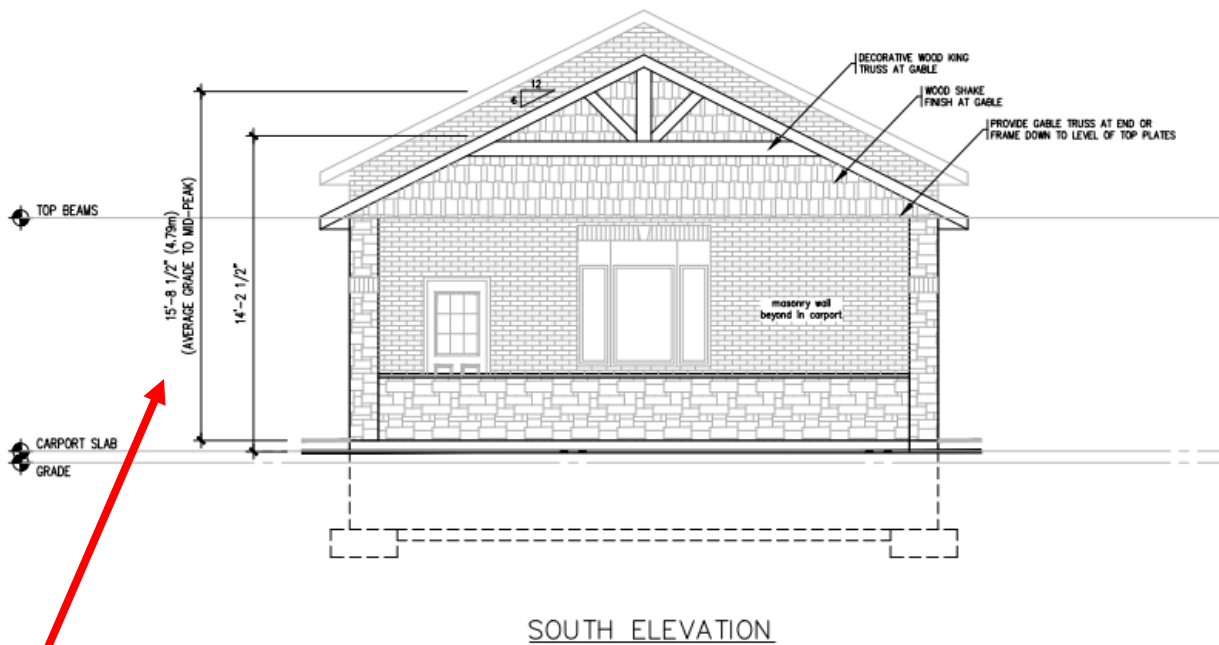
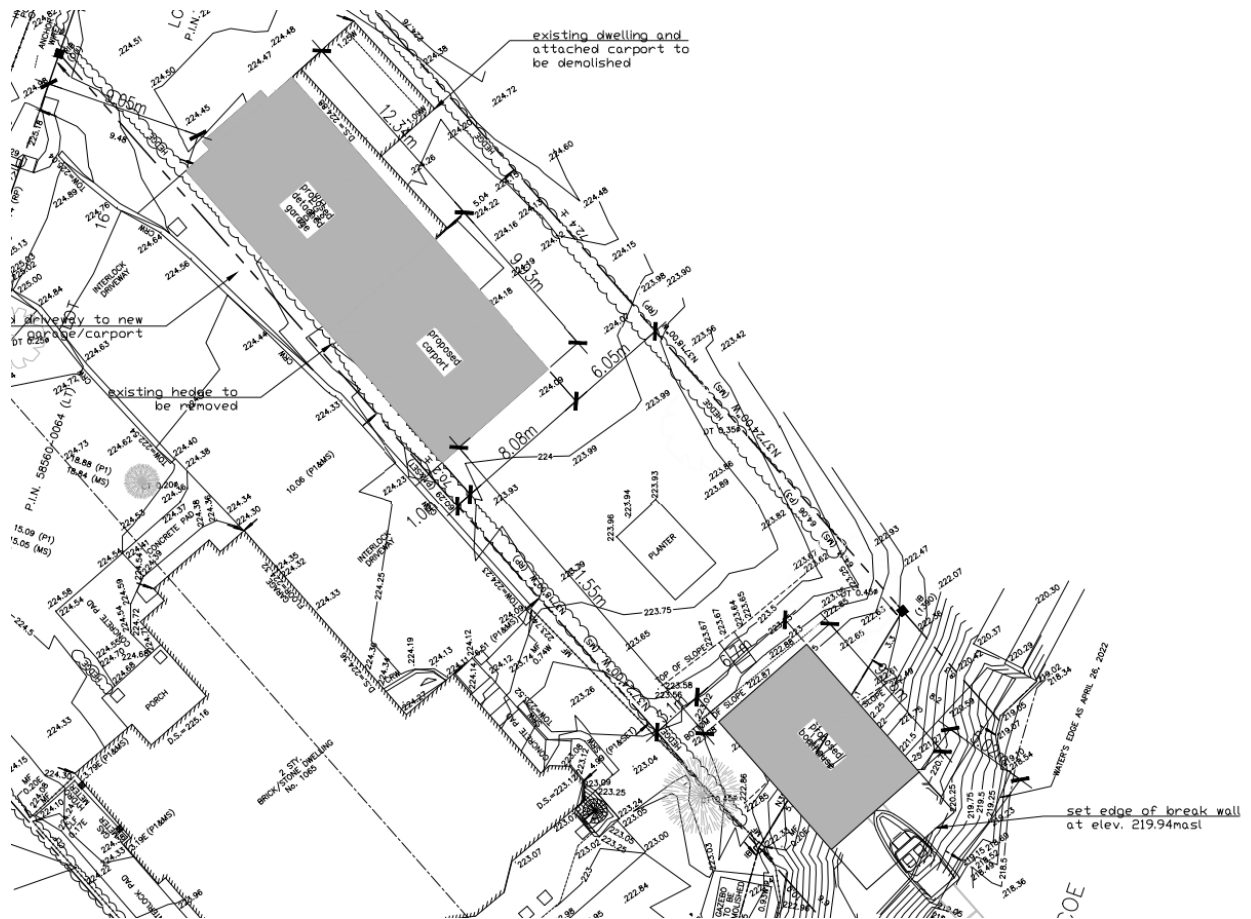

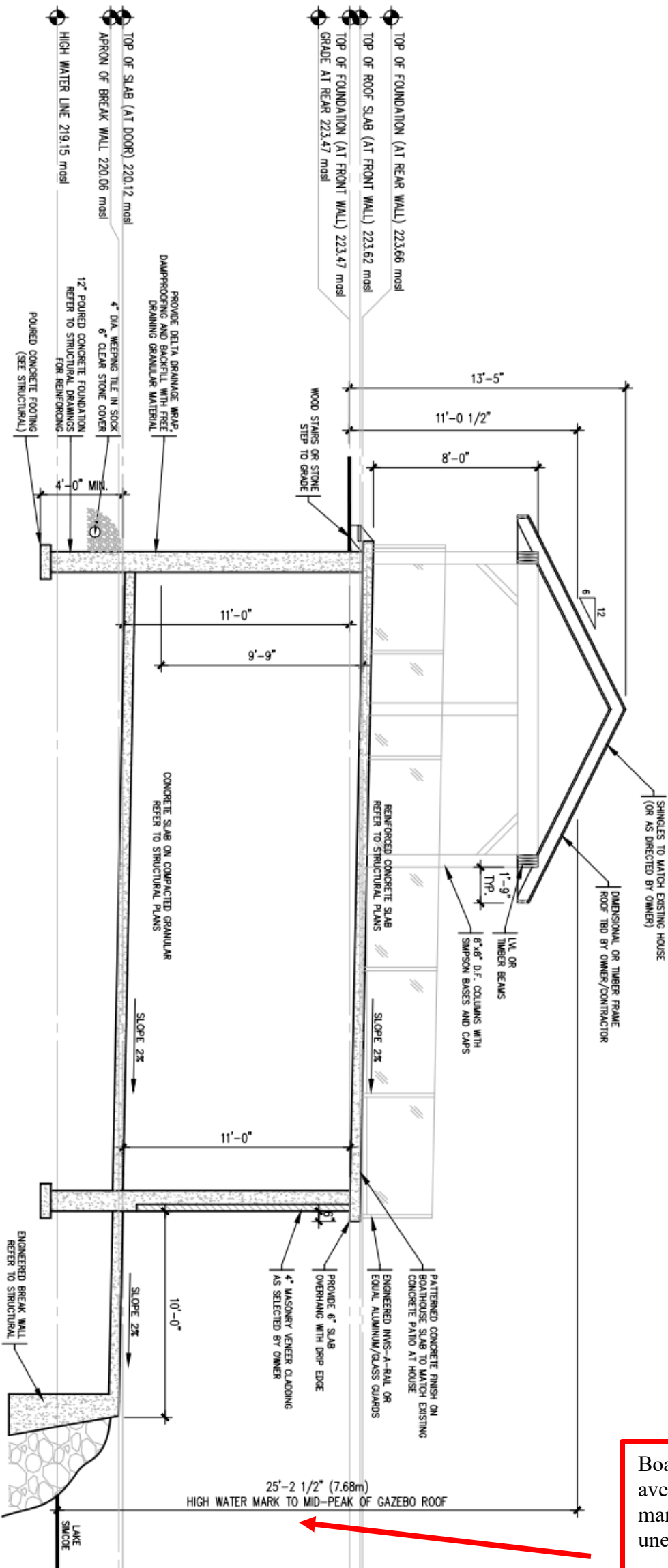
