Purpose: The applicant is proposing to construct a carport with a maximum size of 19.5 square metres (210 square feet) in their front yard with a 5.4 metre (18 feet) set back from the front property (lot) line. The applicants are seeking relief to the following section of Zoning By-law 97-95, as amended:

Section 5.1.3 a), Permitted locations for detached accessory buildings and structures in the Shoreline Residential Zone not located on Lake Simcoe or Bass Lake.

Required: Not to be located in the front yard.	Proposed: Carport to be located in the front yard, setback 5.4 metres (18 feet) from the front property line.

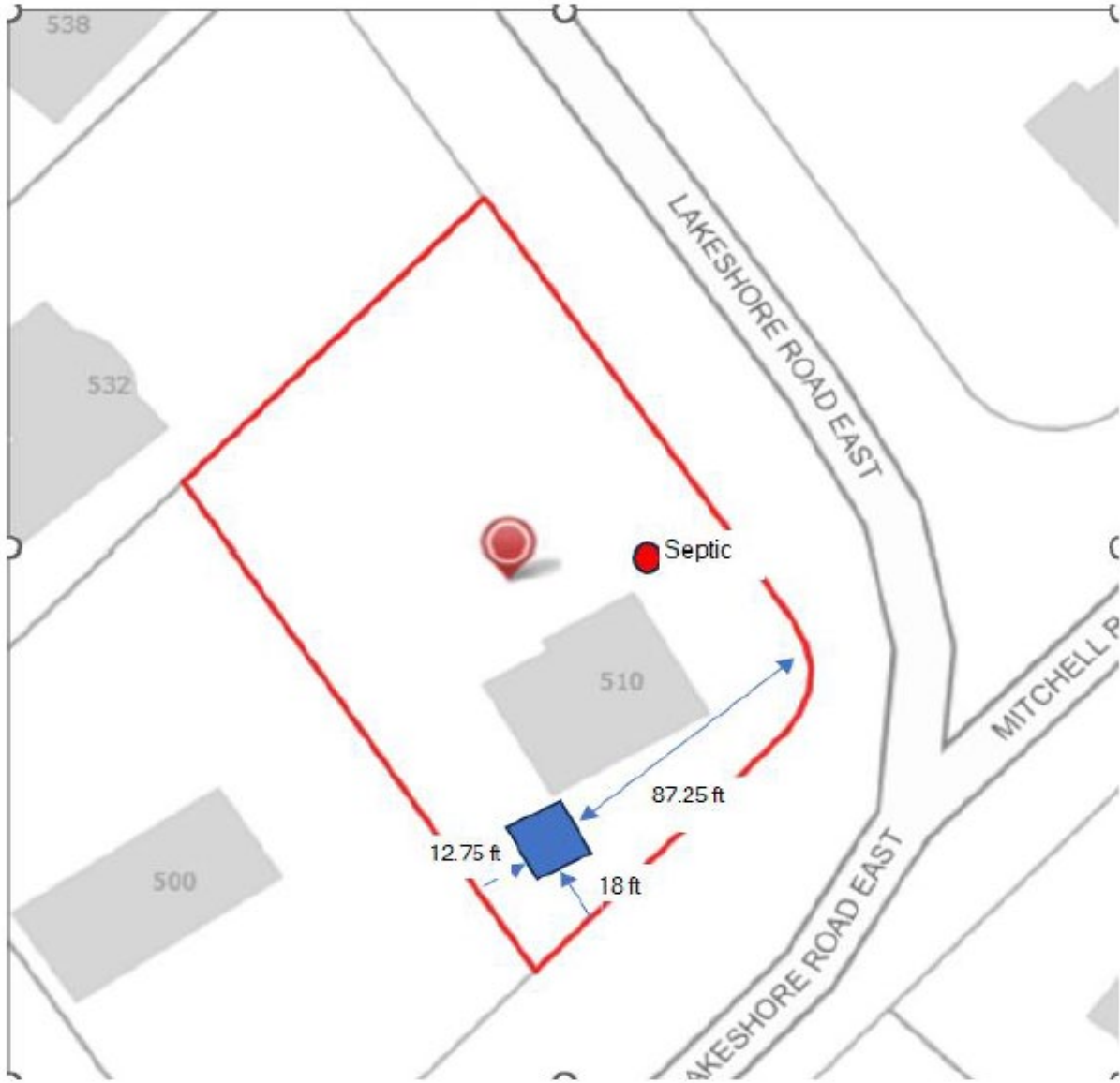
