**Purpose:** The applicant is proposing to demolish the existing dwelling and construct a new single detached dwelling with hardscaping patio at the rear of the dwelling to accommodate a swimming pool and hot tub and is seeking relief to the following section of Zoning By-law 97-95, as amended:

### Section 5.31 – Setback from Slopes

<b>Required:</b> 23.0 metres (75.5 feet) from Top of Bank or embankment that exceeds 33%.	<b>Proposed:</b> The proposed pool and hardscape patio is proposed to be setback 12.05 metres (39.5 feet) and 16.11 metres (52.85 feet) from the top of bank.
