The Purpose and Effect of the updated Official Plan is to ensure the Township of Oro-Medonte planning policies conform with all current Provincial and County Policies and Plans in accordance with Section 26 of the *Planning Act*. This updated Official Plan will better position the Township for future Official Plan review/updates following the completion of the County of Simcoe's Municipal Comprehensive Review and Official Plan Amendment Process. The updated Official Plan will provide a concise Township planning policy document that transparently outlines all current Provincial and County policies for public awareness in one consolidated document.

**Lands Affected** by the updated Official Plan include all lands within the Township of Oro-Medonte and as such, no key map has been provided in this notice.

**Prior To** adoption of the updated Official Plan, a statutory Open House was held on August 31, 2022 and a statutory Public Meeting was held on September 8, 2022 to receive public input on the proposed updated Official Plan in accordance with Sections 17(15) and 26(3) of the *Planning Act*, R.S.O. 1990. With the adoption of Motion No. DSC221005-6 of the Development Services Committee, Council deems it expedient to adopt the Township's updated Official Plan.

**Public Input** in the form of oral submissions at the Public Meeting and written submissions in advance of and following the Public Meeting, was received by the Township. Details regarding how the public input was considered is available in Township staff report Item 7a) DS2022-124.
