Proposed Agreement Barrie - Oro-Medonte

During the previous meeting between the Mayors and Deputy-Mayors of Barrie and Oro – Medonte, a request was made for Barrie to provide two items.

- 1. An updated written request that Oro-Medonte was able to provide for Council to consider.
- 2. Any proposal to be based upon the deal that was reached between the City of St. Thomas and the Municipality of Central Elgin.

St. Thomas & Central Elgin

Following this meeting, the Mayor of Barrie sought out the details of the agreement between St. Thomas and Municipality of Central Elgin, in order to replicate and offer based on the aforementioned terms. As part of the agreed terms between the two municipalities, St. Thomas is to pay cash in two ways:

- 1. \$10 million in upfront, one-time cash
- 2. \$1 million per annum for five years

The total of this proposal was \$15 million.

Additionally, St. Thomas was to provide 2000 units worth of water/wastewater capacity to convert an area previously used a healthcare centre to residential development. In exchange, St. Thomas received 2000 acres of land for development for the Volkswagen EV Factory. This equates to a ration of 1:1 for acres of land to units of servicing, and a value of \$7,500 of cash per acre. Additionally, the Province of Ontario and Volkswagen provided St. Thomas with contributions for their water/wastewater capacity.

Barrie - Oro – Medonte

Based on the above ratios, Barrie is willing to offer the same terms as has been provided to Springwater on a pro-rated basis. There are roughly 850 acres of land that can be developed in the outlined request from Barrie.

While it is impossible to know the developable area at this point, the City of Barrie would work with the Township of Oro-Medonte until the actual development boundary is determined and delivered based on the ratios established in this offer.
